Parade applications must be submitted by 3:00 p.m. on Monday, December 1st.

Entries are organized to create a balanced mix of floats, bands, walkers, and vehicles. The lineup is determined by the date your completed application is received—so the sooner you apply, the closer to the front you'll be!

Please remember, this is a nighttime parade beginning at 6:00 p.m. All entries must be illuminated so they can be seen clearly along the parade route. Entries without adequate lighting may not be visible to spectators.

We can't wait to see how you showcase Santa's silly side as he takes over Gaffney!

PROCEDURES

1. Every entry must pre-register by completing the parade application form and attaching required documents
2. Parade is limited to the first 100 entries.
3. **ALL PARADE ENTRIES MUST BE ILLUMINATED!**
4. Fee of \$20.00 per entry (Elected Officials not required to pay fee) must be paid at the time of application is submitted.
5. Please note that the City of Gaffney will no longer serve as the intermediary for float rentals. All parade participants interested in renting a float must make arrangements directly with the float rental companies. For your convenience, contact information for these companies is provided below:

6. No sirens or loud horns.
7. **No throwing of any candy, favors or handouts of any kind.**
Failure to comply will result in IMMEDIATE removal and suspension from future participation.
8. ALL entries (motorized and ridden) must remain in the **center** of parade route. No maneuvering and NO riding animals to the spectators for petting, conversing or any other reason.
9. All vehicles must be operated by a licensed driver and proof of insurance is required. This includes golf carts and ATVs. **Proof of current insurance and copy of drivers license for driver must be submitted at time of application.**
10. City will provide traditional Santa at the end of the parade.
11. Floats, trailers, beds, or similar attachments transporting children more than thirty (30”) inches from the ground must have side rails. Rails should measure a minimum of three feet from the floor of the unit.
12. To ensure the safety of riders, all children must be unloaded from floats/open units at the end of the parade route.
13. Parents, or other responsible adults (18 yrs. or older), must be at the end of the parade route to pick up their children.
14. The ratio of adult chaperones to children will be no less than 1:10 for ages 6 to 12 or 1:5 for preschoolers.
15. All animals (including horses) must abide by the City of Gaffney Animal Control laws (**including immediate removal of waste**). Responsible person(s) of animal entries must have someone with the animal throughout the parade (from line-up to parade conclusion) with pooper scooping capabilities. **ALL WASTE MUST BE REMOVED IMMEDIATELY.** **Please see City of Gaffney Animal Control Ordinance on next page**
16. **HORSES:** All horse entries must show proof of liability insurance as respects the horse. If the horse is owned by a farm, you must show a “certificate of liability insurance,” if the horse is owned by an individual, you must provide the “declarations page” of the individual’s “homeowners policy with liability limits”.

****All horses participating in the parade MUST be diapered before removal from the trailer. Additionally, the horses must be accompanied with a pooper scooper for the entire duration of the parade to ensure cleanliness along the route.**

17. **PERFORMANCE AREAS:** The ONLY locations permissible for stopped performances are the following intersections: Buford, Floyd Baker Boulevard and Frederick. Stopped performances can last no longer than 30 seconds.

CITY OF GAFFNEY ANIMAL CONTROL ORDINANCE

Sec. 4-2. - Definitions.

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Animal means all living vertebrate creatures except homo sapiens.

Animal control officer means a person designated by the city as the enforcement officer of the provisions of this chapter, and so designated by the city administrator.

Animal shelter means any premises so designated by the city council for the purpose of impounding and caring for pets found in violation of this chapter.

At large means an animal off the premises of the owner or keeper and not under restraint by the owner or keeper.

Cat means a commonly domesticated member of the feline family, excluding lions, tigers, jaguars, panthers, bobcats, wild cats and the like.

Dangerous or vicious animal means any animal constituting a physical threat to human beings or other animals, or evidencing an abnormal inclination to attack persons or animals without provocation, or having a tendency to do any act repeatedly which might endanger the safety of persons or property.

Dog means a commonly domesticated member of the canine family, excluding wolves, foxes, coyotes and the like.

Euthanasia; euthanize; euthanized means the methods of destruction provided by the South Carolina Code of 1976 for impounded animals.

Exposure to rabies means any person or animal which has been bitten by or exposed to any animal known to have been infected with rabies. This determination shall be made by the state department of health and environmental control as provided for in state law.

Kennel means any person or organization engaging in the business of breeding, buying, selling or boarding of animals.

Neutered pet means any dog or cat which has been operated on to prevent conception.

Owner or keeper means any person who has a right of property in an animal; keeps or harbors an animal, or has it in his care or acts as its custodian; or permits such animal to remain on or about premises occupied by the owner or keeper.

Pet means any dog, cat or member of the canine and feline family.

Running at large means off the premises of the owner or keeper and not under the physical control of the owner or keeper by means of a leash or other similar restraining device.

Stray means an animal at large.

Under restraint. Controlled by means of a chain, leash or other restraining device lead by a person physically capable of restraining the animal, and obedient to that person's commands, or securely enclosed within the real property limits of the animal owner's premises, or securely enclosed within the real property limits of property of another with that property owner's permission, or securely enclosed within a vehicle being driven or parked.

Vicious animal means any animal evidencing an abnormal inclination to attack persons or animals without provocation.

Wild, exotic or venomous animal means any animal that, because of its size, disposition or other characteristic would constitute a danger to persons or property.

Sec. 4-20. - Leash regulation.

(a) It shall be unlawful for the owner or keeper of any dog to permit such animal to run at large or to transport an unrestrained animal in an open truck bed. A dog shall not be considered running at large if:

- (1) It is confined to the property of the owner or keeper; or*
- (2) On a leash not longer than ten feet, restrained by a person as defined in section 4-2; or*
- (3) A. In a cage or enclosed interior of a vehicle.*

B. Dogs which are participating in hunting, obedience trials, conformation shows, tracking tests, herding trials, lure courses or agility trials shall not be considered at large.

Sec. 4-24. - Animal waste*

The owner or keeper of every animal shall:

- (1) Be responsible for the immediate removal of any excreta deposited by his animal on any property other than his own;*
- (2) Prevent the accumulation of animal waste on any property;*
- (3) Dispose of a pet's waste by either flushing or bagging and depositing it in the garbage or by burial.*

*** PLEASE NOTE THAT ANIMAL WASTE PERTAINS TO ALL ANIMALS INCLUDING HORSES. IT IS THE RESPONSIBILITY OF THE RIDER OF EACH HORSE TO PROVIDE MEANS FOR IMMEDIATE REMOVAL IN ACCORDANCE WITH SECTION 4-24 SHOWN ABOVE.**
